

Affidavit of impeachment of the Student Government Association for Malfeasance

Esteemed Members of the Student Senate of the Student Government Association at the University of Central Florida,

Whereas, Title VII Chapter 701 Section 701.1 of the Student Body Statutes specifies that any student at the University of Central Florida may file an affidavit for impeachment against any Student Government Association Agent;

Whereas, Title VII Chapter 701 Section 701.2 of the Student Body Statutes specify that any charges or complaints of wrongdoing may be filed by the student in affidavit form;

Whereas, Title VII Chapter 701 Section 701.2 of the Student Body Statutes specify that the Affidavit must include a description of what alleged wrongdoings were conducted and that the student may, but is not required to, list the provision of the Student Body Constitution, Student Body Statutes or Senate Rules that are alleged to have been violated;

Whereas, Title VII Chapter 700 includes Malfeasance as an offense punishable by impeachment;

Whereas, Title VII Chapter 700 defines Malfeasance to include the willful disregard of the Student Body Constitution;

Whereas, Article VI Section 3 of the student body constitution states that Graduate Students shall receive funds from Activity and Service Fees;

Whereas, Article VI Section 3 of the student body constitution stipulates that funds received by Graduate Students from Activity and Service Fees are Graduate Student Assembly fees;

Whereas, Article VI Section 3 of the student body constitution states that Graduate Student Assembly fees shall be allocated to the Graduate Student Assembly by the Activity and Service
