NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the, 16 of March 2012 at 11:45 AM at [redacted] (Zone: 22) in Orange County did

On the morning of March 16, 2012 I had responded to the Student Conduct office at the University of Central Florida for the purposes of witnessing Mr. Matiace Noel being given an order to leave campus by administrators (trespass warning). This order was affected in my presence and Noel was to leave after finishing up some administrative matters with the University.

A few minutes' later officers were dispatched to Academic village in reference to a suspicious person walking around. It was the same basic description as Noel. Officer Pete Stevens stopped this person which turned out to be Noel. As Stevens had knowledge of Noel previously being warned to leave the property but believed Noel was doing so at the time. Enrique Jimenez who is a maintenance worker for the University notified Stevens that Noel was groping women nearby. Stevens stopped Noel again a short distance away and took Noel into custody.

Officer P. Dejesus located Miss [redacted] and Miss [redacted] at building [redacted] at the University. This building is a dorm building. Also present was Jimenez.

Jimenez told me he heard arguing in the hall that sounded very serious. When Jimenez went to investigate he observed a female walking toward him and Noel following her. [redacted] told Jimenez that Noel "grabbed" [redacted] r by her Vagina, while at the same time trying to gain access to her room. Jimenez said he asked Noel if Noel lived here and didn't get a response from him. According to Jimenez, Noel started leaving the area, while at the same time cursing at [redacted] and [redacted]. Jimenez made a call and kept Noel in sight until the arrival of police. Jimenez observed Stevens take Noel into custody. Jimenez said that he did observe Noel go past the doorway to the dorm room (going inside the room) while [redacted] and [redacted] continued to push him out with their hands.

[redacted] told me that she does not know Noel and has never had any kind of relationship with him. Although according to [redacted] she has seen Noel around before. According to [redacted] Noel gives the girls weird looks. [redacted] said she started walking in the direction of building 109. [redacted] let Noel in the building because she believed he may have business in the building and was trying to be courteous with Noel. Once inside the building Noel said to [redacted] "I like what you got on". [redacted] said "what", when Noel repeated his statement again. [redacted] told Noel that the girls think he is weird. Noel then proceed to touch [redacted] breast area through her outer clothing. [redacted] left the main floor of the building and took the stairs in an attempt to get away from Noel. According to [redacted] once she got on the second floor, she attempted to go to a friend's room, which was not there. [redacted] told Noel never to touch her again. Noel at this time touched [redacted] breast area again. [redacted] told Noel really loud "get the fuck off me". [redacted] started pushing Noel off of her, but Noel continued what he was doing. [redacted] dropped some belongings she was carrying so she could continue to fight with Noel. Noel continued to touch her breasts harder. Then Noel put his hands on [redacted] vagina (through [redacted] outer clothing). According to [redacted] Noel touched her breasts over and over again with no hesitation. [redacted] made it to a friend's room in the area, for which she had a key to. Noel followed [redacted] into the room ([redacted] without being invited. [redacted] banged on the interior door of [redacted] room in an attempt to get help, while at the same time telling Noel to leave her alone. While inside the dorm room, [redacted] told Noel to get out and Noel refused to do so. [redacted] said that due to Noel's conduct, she was not only in fear of her safety, but also in fear of being raped.

[redacted] told me that she heard [redacted] banging on her door and because of the way she was screaming, [redacted] knew this was serious. When she opened the door [redacted] observed Noel trying to approach [redacted] and touch her. Also Jimenez was telling Noel to leave the room. Noel did not comply. [redacted] went into [redacted] interior room, while at the same time [redacted] pushed Noel out with her hands. [redacted] eventually pushed Noel out of the room, but while inside Noel told her that he will swing on her (commit battery). At that time [redacted] did observe [redacted] belongings laying in the outer hall. Noel attempted to take a beach ball that belonged to [redacted] which was one of the items in the hall. Noel would not give it back, so [redacted] took from Noel by force. Meanwhile [redacted] said to Noel "so is that how you feel you can touch on a female" and Noel said "yes, I can do whatever I want".

NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the, 16 of March 2012 at 11:49 AM at ACADEMIC VILLAGE (Zone: 22) in Orange County did

Commit the offense of trespass after warning.

On 03/16/2012, the defendant appeared in the office of student conduct at the University of Central Florida, a post secondary educational institution under F.S.S. 1012. The defendant is a student, registered in classes and living in the dormitory, Citrus Hall. He was summoned to the office to receive a disciplinary notice and suspension from the University due to previous criminal charges, UCF PD case number 2012-0772 which occurred in the Academic Village building [redacted]. In that case, the defendant is alleged to have possessed cannabis and was arrested for that charge.

While appearing at the student conduct hearing today, Officer Thomas Beeson gave the subject a written trespass warning after the Director of Student Rights and Responsibilities, Dana Juntunen, told him he was no longer allowed to be on campus. The trespass case number is 2012-0806 and was issued at approximately 1100 hrs, on 03/16/2012.

Instead of leaving the campus directly, the subject left the student conduct office and proceeded to the area of Academic Village, Building [redacted] where he committed another offense. Workers from the maintenance staff heard a commotion involving the subject and followed him from building [redacted] to the B8 parking lot on the west side of the Academic Village. They were the ones who originally made the call on this case of the subject being a suspicious person. I originally was not made aware of the criminal charges and released the subject to continue on his way off campus, rather than arrest him for the trespass after warning for the round-about route that he was using to get off campus. After determining that the defendant was not just slow in removing himself but actually committed another crime, case number 2012-0810, I made contact with him again in front of the Barbara Ying Center, just west of the B8 parking lot and took him into custody.

The defendant failed to leave the campus as part of his original trespass case and instead went to Academic Village. I contacted him while he was still on the campus in the parking lot in front of the Barbara Ying Center. The subject was arrested and taken to the UCF Police Department for processing. He was then taken to the Orange County Jail for processing.
