On the morning of March 16, 2012 I had responded to the Student Conduct office at the University of Central Florida for the purposes of witnessing Mr. Matiace Noel being given an order to leave campus by administrators (trespass warning). This order was affected in my presence and Noel was to leave after finishing up some administrative matters with the University.

A few minutes' later officers were dispatched to Academic village in reference to a suspicious person walking around. It was the same basic description as Noel. Officer Pete Stevens stopped this person which turned out to be Noel. As Stevens had knowledge of Noel previously being warned to leave the property but believed Noel was doing so at the time. Enrique Jimenez who is a maintenance worker for the University notified Stevens that Noel was groping women nearby. Stevens stopped Noel again a short distance away and took Noel into custody.

On 03/16/2012, the defendant appeared in the office of student conduct at the University of Central Florida, a post secondary educational institution under F.S.S. 1012. The defendant is a student, registered in classes and living in the dormitory, Citrus Hall. He was summoned to the office to receive a disciplinary notice and suspension from the University due to previous criminal charges, UCF PD case number 2012-0772 which occurred in the Academic Village building In that case, the defendant is alleged to have possessed cannabis and was arrested for that charge.

While appearing at the student conduct hearing today, Officer Thomas Beeson gave the subject a written trespass warning after the Director of Student Rights and Responsibilities, Dana Juntunen, told him he was no longer allowed to be on campus. The trespass case number is 2012-0806 and was issued at approximately 1100 hrs, on 03/16/2012.

Instead of leaving the campus directly, the subject left the student conduct office and proceeded to the area of Academic Village, Building where he committed another offense. Workers from the maintenance staff heard a commotion involving the subject and followed him from building to the B8 parking lot on the west side of the Academic Village. They were the ones who originally made the call on this case of the subject being a suspicious person. I originally was not made aware of the criminal charges and released the subject to continue on his way off campus, rather than arrest him for the trespass after warning for the round-about route that he was using to get off campus. After determining that the defendant was not just slow in removing himself but actually committed another crime, case number 2012-0810, I made contact with him again in front of the Barbara Ying Center, just west of the B8 parking lot and took him into custody.

The defendant failed to leave the campus as part of his original trespass case and instead went to Academic Village. I contacted him while he was still on the campus in the parking lot in front of the Barbara Ying Center. The subject was arrested and taken to the UCF Police Department for processing. He was then taken to the Orange County Jail for processing.
