s stated she met Floyd on May 12, 2011, while on a dating web site, Match.Com. They had a conversation via email and eventually exchanged cell phone numbers where they continued to talk and eventually agreed to meet in person. During their conversations Floyd would ask her question's that were sexual in nature which she told him that she only had one boyfriend and was not experienced. comfortable with the things he was asking her.

On May 13, 2011, at approximately 2000 hours, they met at the Orlando Alehouse in Sanford where they are dinner and had conversation. stated they ended the night with a kiss and planned on seeing each other again.

and Floyd agreed to meet at a location in Sanford and eventually she followed him to his apartment. While at the On May 14, 2011, apartment sitting on his bed watching television, they began to kiss. Floyd then began to perform sexual acts on without her consent. She told him no and that she did not want to have sex with him. He took her pants off, AFloyd then forced her to give him onto her back attempted to get up and use the restroom and he told her "your not going anywhere". At one point Floyd turned A At one point he inserted and when doing so scratched her ankle and then stated Floyd again made her give 🛊 because he Floyd then pulled back and c

got up, went into the bathroom, got dressed and when came back into the bedroom, saw Floyd lock the door. She stated he was acting very nervous, Pacing back and forth in the bedroom and said "I don't know what to do with you now?" He wanted to go the pharmacy and buy her the morning after pill to prevent pregnancy. Floyd grabbed her arm and they drove in his vehicle to a local pharmacy where he made her purchased the pill and got back into the purchase the pill. She went into the store, ran into the bathroom crying not knowing what to do. stated she was in fear of what he would do if she did not go to the store and take the vehicle where he made her take the pill with water. pill. They arrived back at his apartment where she then left in her vehicle and drove home. made contact with her mother and then stated at no time did she consent to any of the sexual acts came to the Sheriff's Office where the sexual battery was then reported. performed on her and she wished to prosecute Aaron Floyd for sexual battery.

was taken to the Seminole County Health Department where a sexual assault exam was conducted. The exam revealed several reddened areas on her body to include her neck, arm, shoulder, and a scratch on her left ankle. There were several lacerations noted in the gual and a wardigharea consistent with the amount of force that occurred during the incident.

On May 16, 2011, at approximately 1550 hours, I made contact with Aaron Daniel Floyd, white male, date of birth at his residence, , Seminole County, Florida. I read Floyd his Miranda Rights in which he agreed to speak with me. I then conducted a sworn digital recorded interview with Floyd. Floyd stated he did meet on the dating web site, Match, Com where they exchanged emails and text messages. Floyd said that on May 14, 2011, at approximately 2000 hours, they did go to his apartment and while there

Floyd provided me with written and verbal consent to search his bedroom, his computer and cell phone. Photographs were taken of the bedroom and the bed sheets, pillow cases, comforter and a brown towel were collected and entered into evidence. I collected his computer tower and his cell phone were it will be examined at the Seminole County Sheriff's Office.

Aaron Daniei Floyd was placed under arrest for sexual battery and transported to the John E. Polk Correctional Facility on a 10,000 bond.
