The Office of Student Conduct has received an incident report alleging violations of UCF's Organizational Rules of Conduct as outlined in The Golden Rule student handbook.

Incident description:

On 4/12/11, [REDACTED] signed a hotel room agreement for 32 guest rooms at the Embassy Suites Downtown Orlando located at 191 E. Pine Street, Orlando FL. [REDACTED] signed under the terms of the agreement using the group Irish Dance and led the sales team to believe that this was a young girls organization in town for a performance.

On 4/22/11, the members of Delta Delta Delta Sorority showed up using the room agreement made by [REDACTED]. After questioning some of the members it was determined the group was here for a spring formal.

The group then brought alcohol out to the pool area and underage drinking took place. After being asked several times to stop the drinking and threats of removal from the property the group allowed the drinking to take place behind closed doors. The group was swearing in front of children and other guests and continued with this poor behavior well into the evening.

At one point the gentleman in [REDACTED] streaked the hotel and was removed by hotel staff. Several other rooms belonging to the above mention were asked to leave by Orlando police. All in all, the hotel compensated other guests of the hotel due to various noise complaints and for the group being rude a total of \$1,166.92.
