Incident description:

On Thursday August 24, 2011, Belinda Boston the Director of Fraternity and Sorority Life arrived at the Sigma Chi House between 7:00 and 7:30 AM. Upon arrival Belinda observed numerous beer cans scattered throughout the parking lot of the property and empty cups sitting on top of cars in the parking lot. Belinda went to the front door of the facility and rang the doorbell where she received no response. Belinda then, called Director for the Sigma Chi Fraternity. Immediately walked outside from the back of the Sigma Chi house and invited Belinda to come inside. While entering the facility the inside of the house had a strong order of Alcohol in the air. Belinda walked into the House Directors apartment where the President and other E-Board member had assembled. Belinda walked into the room and took a seat at the desk and began to have a conversation with the President. Belinda asked Sigma Chi President, what happened at the facility the night before. that individuals came to the House for "Pre-Gaming." Belinda asked what does that mean. that individuals stopped by the house the night before to hang out and drink before going out to the local bars. also stated the Pre-Gaming was not an organized event by the chapter, stated it was just individuals getting together. Belinda then proceeded to explain why she'd stopped by. Belinda delivered the news to the E-Board members and the House Director that an individual who attended the party the night before had passed away. and the House Director informed Belinda that the police and Detectives had been by the house several times to ask questions about the events from the night before. The House Director stated they were cooperating fully with the police and would do what was needed or asked of them. and the other E-Board members looked visibly shaken by the news. The President also appeared to be unfocused and unclear about the events taking place. was called and made aware of the current situation. After we While in the apartment the advisor engaged in conversation for 30 to 45 minutes, Belinda stated that we in FSL were here to support the chapter though this difficult time. Belinda asked asked were walking towards the door if she could take a look around the house. didn't object. Belinda walked into the kitchen space and the chapter room where empty beer cans, vodka bottles, and cups were sitting in plain sight. Belinda stated to that the house and property were a mess and it needed to be cleaned as soon as possible. agreed and stated he would take care of the matter.

Based on information received from individuals who were present the night of Wednesday, August 24th as well as information gathered from staff investigation, here is what I can report.

On the night of Wednesday, August 24th, between the hours of 9pm-2am, Sigma Chi fraternity had an unregistered event where alcohol was present at their fraternity house. This event was considered a "pre-game" and a time to hangout according to the members of Sigma Chi. The men of Sigma Chi invited women from Delta Delta Delta sorority over to their house as early as Monday, August 22nd to come over on the 24th.

On the night of the 24th, women entered Sigma Chi from the back door into the common area where the majority of participants hung out. It has been determined that there were anywhere between 60-200 people in attendance throughout the night. The attendees were predominately Sigma Chi and Delta Delta Delta members. During the event, there were various drinking games occurring including flip cup and beer pong. These drinking games were occurring in the common area. It has also been determined that as the night progressed, hard liquor shots were passed around. According to members of Sigma Chi and Delta Delta Who were in attendance, no alcohol was being served from an actual bar in Sigma Chi. However, leaders from both organizations as well as individuals present at the gathering acknowledged that underage drinking was occurring.

Based on the information provided, it is clear that both Sigma Chi fraternity and Delta Delta Delta Sorority were in violation of various policies both from their National offices as well as the University. Specifically, Sigma Chi held an unregistered event where alcohol was present, underage drinking was occurring, drinking games were being played, and the gathering was presumably an open party, which are all violations of various policies. Members of Delta Delta Delta should have known that this was an unregistered event, engaged in the drinking games at Sigma Chi, and acknowledged that their underage members were drinking.

At the time of this report, both organizations have been placed on various probations both from their National offices as well as the University.


