NARRATIVE:

The undersigned has probable cause to believe the above-named defendant on the, 17 of March 2012
at 11:40 PM at 12289 UNIVERSITY BV (Zone: 22) in Orange County did

On the above dates and times while working an agency approved off duty detail at the Knights Library (College bar) for a St. Patty's day block party, I was removing a large group of party goers that were blocking the exit of the bar. The defendant was asked to leave and stated "Fuck You, I've been waiting here all day" I placed my hands on the defendants arm and I directed him away from the exit. The defendant resisted my lawful order by pulling away and swung at me with his fist in an attempt to punch me. I took evasive action to avoid being punched as the defendant fled on foot southbound through the parking lot towards the El-Cerro Mexican restaurant. I lost sight of the defendant but a search of the surrounding area was conducted and the defendant was located hiding under a parked vehicle. I positively identified him as the same individual as the one who just ran from me. The defendant was ordered to come out from under the vehicle, which he did; however as myself and Deputy Scott Sampsel attempted to place handcuffs on him, he began to actively/physically resist us by swinging his body and pulling away from us. As the defendant attempted to flee on foot again, I grabbed him by the waistband of his pants. The defendant then turned and punched me in the chest with a closed fist. The defendant was re-directed to the ground where he continued to strike me. Deputy Sampsel deployed pepper spray and after a short physical altercation the defendant was secured with handcuffs. During this incident I was wearing my standard OCSO class "B" long pant uniform. Statements were obtained by bar security/bouncers. Fire/Rescue # 08 from Seminole County responded and treated the defendant for the use of pepper spray on the defendants face. Cpl. Rob White responded and conducted an OCSO Supervisor interview of the defendant for any possible injuries known or unknown. The defendant was transported to BRC for processing without further incident.

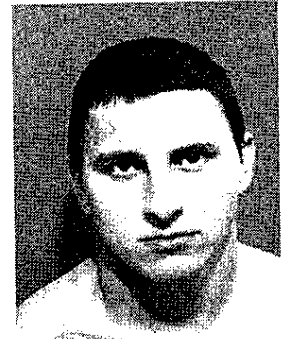

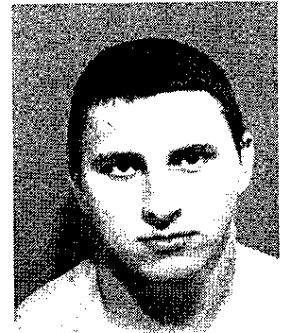
