Modus Operandi: Victim was approached by two suspects who punched him in the face and took his money. Detailed description of suspect(s): Both suspects were Hispanic males approximately 6'00 in height with a thin build. One had short hair and the other was wearing a dark hoodie. The victim was unable to get a good look at either.

Detailed weapon description: No weapons were seen.

Detailed description of disguise(s) worn: None

Scene investigation: The parking garage of Sterling apartments does not have any cameras. [REDACTED]

Is the victim a tourist or student: The victim attends Valencia College.

Detective notified: Night Investigations Squad was notified of the incident.

On 11/11/14 at 0021 hours, I responded to Oviedo Emergency Room, located at 8300 Red Bug Lake Road in reference to a robbery that occurred at 12100 Sterling University Lane.

When I arrived, I met with Khandakar Faiyaz Ahsan (Victim) who stated the following:

On 10/10/14 around 2230 hours, Khandakar was walking in the north parking garage of Sterling University apartments when he heard someone behind him say "hey". As he turned around he was punched on the right side of the face by an unknown white Hispanic male approximately 6'00 tall with a thin build and black hair. When he was hit he dropped to the ground and dropped his phone wallet on the ground. Another Hispanic male wearing a dark hoodie picked up his wallet and took \$5.00 from it while the first male punched him again on the same side of the face. Both suspects then left on foot in an unknown direction. Khandakar believes he will be able to identify the male that hit him if he saw him again.

After the suspects left, Khandakar continued to his friend's apartment and tried to clean himself up. About 30 minutes later they then found a security guard who called 911. Khandakar briefly met with a UCF PD officer and then had his friends drive him to the Oviedo Emergency room.

At this time the doctor at Oviedo ER believes Khandakar's jaw is broken, but cannot confirm until all testing is completed. He has lacerations to the inside of his mouth and swelling to his face. Khandakar was able to talk

with me, but had slight difficulty moving his mouth. He completed a sworn written statement and advised he did not give anyone permission to hit him and take his property. He is willing to testify in court and prosecute criminally. He was provided with a business card, with case number and photo referral notice. He also completed a release of confidential information form.


Night Investigations Squad was notified of the incident.
