Just to clarify, the report states conduct sent this to UCFPD — I want to ensure conduct has no responsive records pertaining to this UCFPD report.

I just want to understand the process and how this instance of alleged hazing — that was being investigated for criminal charges by UCFPD — was not fully investigated by the office of student conduct.

It does not appear the university group was on an interim suspension based on your email. Does UCF have a comment to the Greek organizations who spend months on interim suspension while going through witness interviews with OSC over something like an anonymous post? Why did Xavier Shannon not send these individuals emails requiring them to attend MANDATORY witness interviews?

So just to make sure I'm on the same page, the Office of Student Conduct was not aware of this until December (if I am understanding the report correctly). UCFPD investigated first, and still has not placed any part of this team on a suspension, or the coach for withholding information? The incident is said to have occurred in August. Why is this university group being treated so differently? Why aren't actions being taken like they would against the Greek Community?

From the report, it appears the "reporter" waited until the end of the fall semester to report this "College hazing-risk of injury or death" incident. Football season and a significant portion of basketball games were played by the time this was reported. The report states UCFPD received this report FROM OSC.
